This indemnification shall include, but not be limited to, damages awarded against the city, if any, costs of suit, attorneys' fees, and other expenses incurred in connection with such claim, action, or proceeding whether incurred by the sidewalk vendor, city, and/or the parties initiating or bringing such proceeding;

City of Torrance Sidewalk Vending Business License Requirements and Regulations

Senate Bill ("SB") 946 was signed into law on September 17, 2018, and became effective January 1, 2019. SB 946 limits the authority of cities and counties to regulate sidewalk vendors, except in accordance with California Government Code Sections 51038 and 51039. On October 15, 2019 the Torrance City Council under the authority provided by SB 946 adopted ordinance #3851 adding a new chapter to the Torrance Municipal Code (TMC). The new chapter 14 of Division 4 to the TMC, Sections 414.1.010 to 414.1.414. The new chapter in the chapter in the TMC finds that the time, place, and manner regulations and requirements provided herein are directly related to the City's purpose of protecting the health, safety, and welfare of its residents, businesses and visitors.

Per TMC 31.2.5 a business license is required to operate a business in the City of Torrance.

Applicant cannot commence business without first obtaining approval from the City of Torrance by obtaining a business license and permit sticker for their cart.

The Sidewalk vendor application will be routed to various City divisions to obtain approvals ensuring the regulations and requirements are complied with, protecting the health, safety, and welfare of its residents, businesses and visitors.

The applicant will:

- 1. Complete all parts of the business license application, and pay the appropriate fees,
- 2. Complete all parts of the supplemental sidewalk vending application.
- 3. Read and fully understand the City's handout on the TMC sections regulating sidewalk vendors.
- 4. Provide a valid government issued picture identification, such as a California Driver's License number, California Identification Card number, or other government issued ID.
- 5. A copy of a valid California's seller's permit pursuant to Revenue and Taxation Code Section 6067.
- 6. Provide names and contact information of all person that will be employed as sidewalk vendors by the licensee's business.
- 7. If a vendor of food or food products, proof of all required approvals and permits from the Los Angeles County Department of Public Health.
- 8. If a vendor of food or food products, proof of certificate of competition of a food handler course.
- 9. If a sidewalk vendor will be using a push cart provide a photo of the vending cart and any signs that will be affixed to the vending cart.
- 10. For as long as the license is active obtain and maintain liability insurance \$1 Million per occurrence and \$2 Million aggregate. If I employ any employees to work in the company as a street vendor the primary applicant will obtain and maintain worker's compensation insurance in addition to the liability insurance.

- 11. For sidewalk vendors using a vending cart must provide a picture of the cart including any signs that will be affixed to the vending cart.
- 12. The principal business owner to execute (sign) indemnification.
- 13. Provide any applicable proof by the City to be in compliance with Article 1 of Chapter 10 of Division 4 of the Torrance Municipal Code for Stormwater and urban runoff pollution control

Criteria for Approval or Denial of Permit

The Director, or his or her designee, shall approve the issuance of a permit unless he or she determines that:

- A. Information contained in the application, or supplemental information requested from the applicant, is materially false, misleading, or fraudulent;
- B. The applicant has failed to provide a complete application, after having been notified of the requirement to produce additional information or documents; or
- C. The applicant has failed to demonstrate an ability to conform to the prohibitions, restrictions, and operating standards set forth in sections 414.1.100, 414.1.110, and 414.1.120.
- D. The applicant has failed to pay any previous administrative fines, complete any community service, and/or complete any other alternative disposition associated with a previous violation of this chapter; or
- E. The applicant has been convicted of a felony or misdemeanor involving moral turpitude, and has not subsequently demonstrated rehabilitative characteristics.

If the permit is denied, written notice of such denial and the reasons therefor shall be provided to the applicant.
